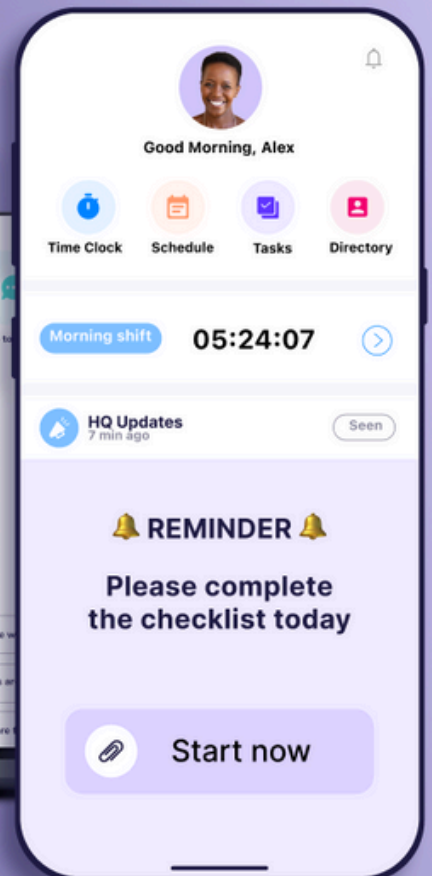
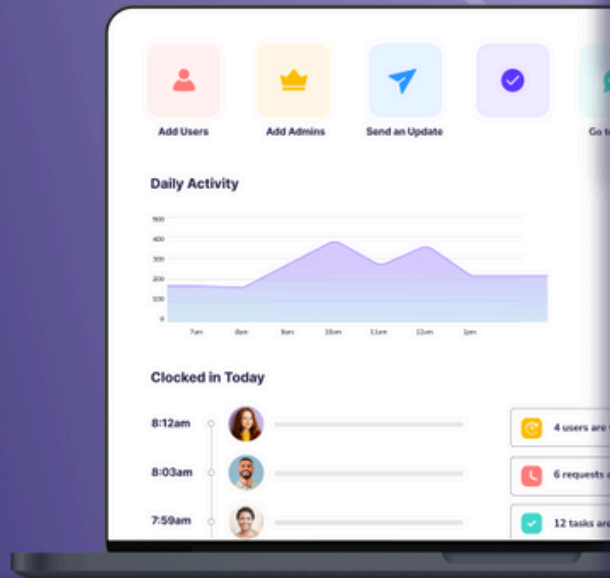


Fire Safety Audit Checklist
